Hi Christian,

My understanding about FAQs was always been that they aren't supposed to be updated until the Project is (re-)published, just like making changes to rich-text page content. Maybe that hasn't been the case in reality, but it's what I assumed was supposed to happen.

Since many of our content editors, like Sara, may be assuming that content won't get posted until the CSRC Admin has published the changes, if there's a way to implement the FAQs that way, I think that would make the most sense.

Is that feasible, without too much extra work right now?

- 1. This page seems to publishing without me checking it in or requesting publishing. I made a change back today, but still have it checked-out and they change is on the live site
 - a. In this situation it was good because the editing I was doing yesterday was showing up live today and I didn't want it to show up yet. So I was able to change it back. However, this shouldn't be the norm, right?
- 2. When one the recent updates was released, the FAQs started sorting alphabetically.
 - a. We'd like to have the ability to order the FAQs in the order we choose. I thought about putting numbers (01. 02. 03.....) however, that is time consuming since you have to open each FAQ record to add the number. In the past, we have removed an FAQ when it is no longer relevant, which would mean going in and renumbering them all again.
 - b. Any thoughts on a resolution? I didn't know if in a future release we could have the up and down arrows to move the FAQs into our chosen order (similar to what we

can do in the Contacts).
