REMINDER – There is an Email List Migration MEETING TODAY (Thurs., Aug. 15) at 1:30 in Lecture Room B in 101. Justin (OISM) and his OISM team are going to discuss the decommission of the email list server that hosts email lists and provide suggestions and guidance on what to do & how they will help with migration of your list(s) to either Google Play or GovDelivery.

NOTE – in my initial email last week, I said meeting starts at 2pm. I somehow got the incorrect time. Meeting START TIME IS 1:30pm.

If you already had your list migrated to Google Groups – I don't think you need to attend this meeting, I believe it is geared more for list owners that are still on the NIST email server.

Thanks everyone that already responded to my email(s) in regards to the email list(s) you are owner (or co-owner) of and for also giving me updated status of the list(s). Appears that a number of you guys already migrated your list(s) to Google Groups & it is just a simple matter of NIST's OISM Team not deleting list from their (NIST) email server logs. And there are some of you that still needs to have your list(s) migrated from NIST email server to either Google Groups and/or GovDelivery. I haven't had a chance to respond to most of your email responses – I got them and I will be updating my list with your list's current status from your email responses.

I apologize if this caused some confusion with some of you in regards to your lists – like I said earlier there was some lack or mis-communication along the way. I had no idea that some of you already migrated your lists to Google Groups. I initially thought this was a new request from OISM that needed to be done.

Over the next month, I will do my best to assist you and OISM in making sure the list(s) gets migrated over to either Google Groups or GovDelivery so there will not be any interruption with your list(s). A couple of you said that you don't use or need list anymore and should be deleted. I will let OISM know those lists and cc the owner of list.

For those that are planning to attend NIST Nobel Prize Bill Phillips talk at 2:30, you can do so (leave LR B about 2:15 to get a seat)

Like I mentioned earlier, I will do my best to help you all out that still needs to have their lists migrated. We have up to Dec. 1st to get this done. But a good rule of thumb – let's not wait for last minute to do this. My goal is to have all of your lists migrated by end of Sept. if not sooner.

Division Colleagues of Email Lists/Alias Email Address Owners,

First – please do not panic about this email in regards to NIST email lists & alias email addresses that you are owners for (present and past lists that are no longer being used today which somehow shows list/address is in active status).

Apparently, the email server that hosts all the below addresses (and across NIST) is going to be decommissioned (retired). NIST system administrators are suggesting that folks have their lists moved to Google Group -OR- GovDelivery. This server is going to be decommissioned by Dec. 1st. There is time to get all of the facts straight and put the list(s) in the right place without interruption of your list/alias address.

I provided the complete list for all of you **BELOW**.

OISM (email team) is going to be hosting a meeting on Thursday, August 15th at 2pm in Lecture Room B (bldg.. 101). Further details will be given at this meeting.

Some of you may already received an email from NIST OISM (Justin?) in regards to your list. Some of you only have 1-2 lists/aliases, and some of you have quite a few.

NOTE: I asked Justin why is webmaster-csrc is on this list? He said that it is a mailing list. I asked him "Do you mean a mailing list with subscribers?" Answer was yes. I told him that webmaster-csrc is NOT a mailing list, it is just an alias email address that we put on all CSRC webpages for our visitors can send us email with inquiries. Then Justin told me that when this alias address was created, they put it on the wrong server (it was something like that).

Here is snippet of what Justin sent me in his email in regards to webmaster-csrc address:
"The server is scheduled to go out of commission December 1st. It's running CentOS 5 and is unable to update itself, so it really should be decommissioned ASAP. This does not affect email aliases, but in your case that email alias was mistakenly set up on email.nist.gov, it should have been an O365 email alias."

Looking at the majority of the lists/addresses below, I have a gut feeling at least 70% of these listed are simply an alias email address and NOT a subscriber email list – like how I oversee the GovDelivery lists for all the publication releases and email notifications we send out.

PLAN OF ACTION:

I will try to email as many of you today (what is left of workday) and finish emailing rest of you on Monday. I will only include the list of list(s)/alias(es) that you were identified as owner of and I will ask you whether this list/alias is an address specifically geared towards receiving emails from the public just like webmaster-csrc OR if your list has subscribers and has multiple folks associated to the address (Ex. A draft document may have about a dozen folks working together and is main channel of communication for draft team) – those kind of lists will need to go to Google Group or GovDelivery. I will ask you to identify each one you are owner of and to what's its purpose or where it should go.

Like I said, we have some leeway in terms of time to get all of these lists/aliases put in the "new" right channel and continue with our daily business as usual.
As the saying goes "We will make it work."

Thanks. I believe a while back I heard wind that OISM was going to do something with the email list/alias but I haven't heard much about it until the other day.
We/I will learn more at this meeting & I hope most if not all of you can attend to learn as well.

I heard that OISM is going to be shutting down the email lists server that I'm sure a good number of folks at NIST use.

My question for you is – Could you please kindly put together a report for me of ALL the email lists that my division (CSD 773) currently has or currently uses to send out emails to their subscribers?

I know of one very popular list is the FISMA list and I believe the list owner(s) is/are: Victoria (Vicky) Pillitteri and/or Jody Jacobs

Not sure if there is an ISPAB list or not.

So I'm hoping you could provide me with this information: list name and who the owner(s) are so that way I can follow up with them to make sure they/we get the lists transferred over to Google groups or if they want to transfer the list to GovDelivery, etc.

Is it possible that you can provide me with the complete list by tomorrow (Wed., Aug. 7th by 2pm)? I see that you have a meeting planned for Aug. 15th in LR B to discuss this and I want to make sure that my folks attend. I plan to attend so I can learn more about this transformation from NIST to Google Groups.

My division values our mailing lists deeply for this is one of the best ways to reach out to all of our subscribers of any new updates that NIST ITL Cybersecurity Program have which we find very important to the subscribers.
