Dustin –

Just sent this to you for I know Jim is trying to wrap up things on his end before he checks out today (in a couple of minutes).

Cool – glad you like what you see on the announcement. As Jim said, just let me know when all the items for the publications are published and I will work closely with you to finalizing the CSRC publication record, publish the CSRC News item & then the GovDelivery notice (which will be sent close to 90,000 subscribers!).

Regarding the SMALL CAPS in the GovDelivery platform (text editor) – Jim is correct; however, I am working with a Tech Support team member from GovDelivery and he is going to try to create a “new” template that I/we will be able to incorporate SMALL CAPS for situations like the 2 algorithms (FALCON, -KYBER) and KECCAK (other document), etc. for future GovDelivery notices. I’m hoping this tech support person will have something to me by tomorrow.

IF he is able to get it working on their end – I will try to get the style updated and send to you. IF he doesn't come through BEFORE the publication gets posted, then I/we will send the GovDelivery notice that you just saw the way it is. NO worries, I'm not wasting time on this – right now it is in GovDelivery's hands to figure out a solution to make it work – it is part of the NIST contract for them to provide us tech support when we need it.

Regarding the SMALL CAPS, so let's say the normal size CAP LETTERS are in font size 12, what size is the SMALL CAPS LETTERS? Is the SMALL CAPS letters 1 font size smaller or 2 size smaller than the normal font size of 12? So if 1 size smaller, then font size would be 11, if 2 font size smaller – then it would be font size 10 or even 8?

Let me know and I will pass that on to the GovDelivery support team.

Thanks. As heads up, I will be working all day tomorrow & everyday next week. There might be a couple of times I may need to step away from my desk for 10-15 minutes – have a puppy dog to take care of and answer phone calls.
