NIST Campus Arrival Instructions:

Please review below important information on accessing the NIST Gaithersburg campus.

All visitors/guests will need to pass a photo identification (ID)* checkpoint.

- **US Citizens please see information regarding the REAL ID Act of 2005 below.*
- *International participants are required to present a passport.*
- *Permanent residents are required to present their Green Card.*

**ALL ATTENDEES MUST BE PRE-REGISTERED TO
GAIN ENTRY ONTO THE NIST CAMPUS.**

Personal Vehicle:

Enter the NIST "Main" Gate located at 100 Bureau Drive, Gaithersburg, MD

- Stay in right lane and proceed to the NIST Visitor Center (small parking lot available)
- Take your **photo ID*** and **vehicle registration** into the Visitor Center; you will be provided a temporary badge that should be worn for the duration of your visit.
- Proceed to the security checkpoint. Please show the paper badge and ID to the security guard. Turn left after the checkpoint. Follow main road to first intersection and turn left. Stay on road until you arrive at Building 222 parking lot. **See attached campus map.**

NIST Metro Shuttle/Public Bus Transportation:

NIST provides shuttle service for official visitors and staff to and from the Shady Grove Metro Station from 6:45 am to 6:10 pm. Visitors using Metro can meet the NIST shuttle at the east side of the Shady Grove Metro Station at 15 and 45 minutes past the hour. The shuttle runs daily from 6:45 am to 6:10 pm. The NIST shuttle will stop at "Bus Bay C." The last NIST shuttle leaves Shady Grove Metro at 6:10 pm. The shuttle returns to the station from NIST on the hour and half-hour from 7:00 a.m. to 6:00 p.m. The shuttle departs from the front of the (b) (6) at 5 and 35 minutes past the hour. The last NIST shuttle leaves NIST at 6:00 p.m. The ride between NIST and the Shady Grove Metro Station takes approximately 15 minutes, depending on traffic conditions. Visitors will need to exit the shuttle at the Main Gate and check in at the Visitor Center for badging purposes. There is a 15-minute walk to (b) (6)

Personal Driver/Uber/Taxi:

Taxis/Personal Drivers are **not allowed on campus**; there is about a 10-minute walk to (b) (6) (b) (6). You will be dropped off at the Visitor Center, located at NIST Main Gate. Follow Metro Shuttle instructions above.

***Visitor Access Requirement:**

For Non-US Citizens: Please have your valid passport for photo identification.

For US Permanent Residents: Please have your green card for photo identification.

For US Citizens: Effective July 21, 2014, under the REAL ID Act of 2005, agencies, including NIST, can only accept a state-issued driver's license or identification card for access to federal facilities if issued by states that are REAL ID compliant or have an extension.
